CERT-In Issues Guidelines On Information Security Practices



To bridge the technical and policy gaps in cybersecurity of government organisations, the Indian Computer Emergency Response Team (CERT-In) has released guidelines on information security practices for all government entities. A recent report by the Cyber security watchdog CERTin states that India witnessed a 53% increase in ransomware attacks in 2022.

All government organisations must also formulate a cyber security policy, assign roles and responsibilities of CISO, and put in place a dedicated and functional cyber security team, according to Cert-In.

These guidelines apply to all Ministries, Departments, Secretariats, and Offices specified in the First Schedule to the Government of India (allocation of business) Rules, 1961, along with their attached and subordinate offices. They also include all government institutions, public sector enterprises, and other government agencies under their administrative purview.

India's digital landscape has witnessed tremendous growth. India has formulated policies aimed at ensuring safe & trusted and secure cyber space for its users.

Over 80 crore Indians (**Digital Nagriks**) are actively utilizing the Internet and cyberspace.This makes India one of the largest connected nations in the world. Citizens are increasingly relying on the Internet to cater to their daily requirements, including aspects such as business, education, finance, and availing digital government services.

Recognising the significance of a secure and trustworthy digital environment, the Government of India has formulated policies aimed at ensuring safe & trusted and secure cyber space for its users. It remains fully aware of the growing cyber threats and attacks present in today's digital world.

They also include all government institutions, public sector enterprises, and other government agencies under their administrative purview.

Government has taken The several initiatives to ensure safe & trusted and secure cyber space. These guidelines are a roadmap for the Government entities and industry to reduce cyber risk, protect citizen data and continue to improve the cyber security ecosystem in the country. They will serve as a fundamental document for audit teams, including internal, external, and third-party auditors, to assess an organisation's security posture against the specified cybersecurity requirements.

The guidelines include various security domains such as network security, identity and access management, application security, data security, third-party outsourcing, hardening procedures, security monitoring, incident management, and security auditing.

Apart from adhering to the best practices in the field they also include guidelines prepared by the National Informatics Centre for Chief Information Security Officers (CISOs) and employees of Central Government Ministries/Departments to enhance cyber security and cyber hygiene.

Lightweight and Portable Payment System



Catastrophic events such as **natural calamities** and **war** have the potential to render existing **conventional payment systems** temporarily unavailable by disrupting the underlying information and communication infrastructure.

Against this backdrop the **Reserve Bank of India (RBI)** is developing a lightweight and portable payment system designed to operate during exigencies such as natural calamities or war.

The proposed lightweight payment system, known as Lightweight Payment

and Settlements System Settlement (LPSS) is being called by the RBI a "**bunker**" equivalent of digital payments. The infrastructure for this system will be independent of the technologies that underlie the existing systems of payments such as **UPI**, **NEFT**, and **RTGS**.

Lightweight and portable payment system is independent of conventional technologies and wired networks that underlie existing payment systems such as **UPI** (Unified Payments Interface), **NEFT** (National Electronic Funds Transfer), and **RTGS** (Real Time Gross Settlement).

Existing conventional payment systems like RTGS, NEFT and UPI are designed to handle large volumes while ensuring sustained availability. These systems are dependent on complex wired networks backed by advanced IT infrastructure.

What is NEFT

National Electronic Funds Transfer or NEFT is a nationwide payments system that allows transfer of funds from one bank's account to another.

What is **RTGS**

RTGS stands for Real Time Gross Settlement. It refers to a funds transfer system that allows the transfer of funds from one bank account to another in real-time and on a gross settlement basis.

Objective of the lightweight payment system

One of the key objectives of the lightweight payment system is to instill public confidence in digital payments and financial market infrastructure, even during extreme conditions.

SemiconIndia 2023



Semicon conferences are organised in different geographies world-wide by SEMI and called **Semicon Europa**, West & East in USA, Taiwan, Korea, Japan etc. where semiconductor industry is established, with the aim to maximise outreach of the technological advancements in the semiconductor domain as well as the policies of various countries to strengthen their semiconductor ecosystem.

Government of India announced USD 10 billion Semicon India Programme with an aim to develop Semiconductors and Display manu facturing ecosystem in India. With an intent to create awareness and showcase India as a potential hub for Semiconductor Design, Manufacturing, R&D and Manpower Development, SemiconIndia Conference 2022 was organised in Bengaluru from April 29 to May 01, 2022.

Building on the success of **SemiconIndia 2022**, **India Semiconductor Mission**, an independent business division of the Digital India Corporation organised its flagship SemiconIndia 2023 at the Mahatma Mandir, Gandhinagar from July 28 – July 30, 2023.

The event is aimed at catalyzing India's Semiconductor ecosystem.

Union Minister of State, Skill Development and Entrepreneurship, and Electronics and Information Technology Raieev Chandrasekhar said, "Through the Semicon India exhibition, young Indians and people associated with technology can learn a lot. In India's techade journey semiconductors and electronics sector will have a huge role to play. In the history of independent India this is the first time that such an effort has met with such success in just 15 months. Our country over the past 70 years either ignored this opportunity or were unsuccessful. Prime Minister Shri Narendra Modi's vision of this ecosystem comprises of design innovation, research, talent, packaging and fabs and we are trying to bring in their associated supply chain further cataysing the semiconductor ecosystem in India."

SemiconIndia 2023 showcased various capabilities of India as a vibrant and sustainable manufacturing destination for global corporations. Top leadership from Industry, Governments, Academia, and R&D institutions shall be leveraging this platform to reflect and usher on key aspects including Ease of Doing Business, building trusted value chains, growth drivers, innovation and startups, and talent pipeline. Spread over a period of three days, the event included following sessions covering various aspects of development of a robust, resilient, sustainable semiconductor ecosystem in India.

AMD to set up largest design center in Bengaluru



US chipmaker Advanced Micro Devices (AMD) has announced its plan to invest approximately \$400 million in Indian over the next five years. The semiconductor giant plans to build AMD new campus in Bangalore with largest R&D facility in the world.Mark Papermaster, Executive Vice President and Chief Technology Officer, AMD, announced the investment plans during the second edition of SemiconIndia 2023 in Gandinagar SemiconIndia 2023 was inaugurated by Prime Minister Narendra Modi.

Investment is expected to create largest AMD design center with addition of approximately 3,000 engineering roles and new Bangalore campus opening before end of 2023, AMD said at **SemiconIndia 2023** in Gujarat.This investment by AMD will include a new AMD campus in Bengaluru that will serve as the company's largest design center, as well as the addition of approximately **3,000 new engineering roles** by the end of 2028. The new Bangalore campus is expected to open before end of **2023**.

Commencing its operations in India way back in 2001 when AMD established its first site in New Delhi, the company today has more than 6500 employees in India. And this new 500,000-square-foot Bengaluru campus will increase the AMD office footprint to 10 total locations across these cities: Bangalore, Delhi, Gurgaon, Hyderabad and Mumbai.

AMD has been an active part of the semiconductor ecosystem in India since 2001 when the company's first site was established in New Delhi. The new AMD campus will increase the AMD office footprint to 10 total locations across these cities: Bangalore, Delhi, Gurgaon, Hyderabad and Mumbai.

India coal production rises 8.4%



The Ministry of Coal has achieved substantial surge in overall coal production with a growth of 8.40% in Q1 of FY 2023-24.

The cumulative coal production has witnessed a significant increase, reaching 222.93 million tonne (MT) as compared to 205.65 MT in Q1 of FY 2022-23.

Coal India Limited (CIL) has recorded an impressive growth of 9.85%, with production reaching 175.35MT in FY 2023-24 as compared to 159.63 MT during the same period the previous year.

Captive mines /others also attained a growth of 4.74 % touching 30.48 MT in FY 23-24 as compared to 29.10 MT in FY 22-23 during the same period. These accomplishments have contributed to the overall positive momentum in the sector.

Simultaneously, cumulative coal dispatch has shown an upward trend, reaching 239.69 MT (Provisional) in Q1 of FY 2023-24, as compared to 224.08 MT in Q1 of FY 2022-23 with a growth of 6.97%. Coal India Limited (CIL) registered 186.21 MT production in Q1 of FY 2023-24 as compared to 176.81 MT in Q1 of FY 2022-23 with a growth of 5.32%.

At the same time, SCCL, & captive/others have recorded 18.07 MT and 35.41 MT in Q1 of FY 2023-24 as compared to 17.30 MT and 29.97 MT in Q1 of FY 2022-23, with a growth of 4.45% and 18.16% respectively. These figures highlight the efficiency of the coal supply chain in ensuring smooth distribution across the country.

Furthermore, the upturn in offtake has resulted in a comfortable coal stock position. The total coal stock as on 30th June 2023 has recorded remarkable growth reaching at 107.15 MT (provisional) as compared to 77.86 MT as on 30th June 2022, reflecting a growth of 37.62%. This growth indicates the

continued efforts to meet rising demand of coal.

India's overall exports in June 2023 estimated at US\$ 60.09 Billion



India's **overall exports** (Merchandise and Services combined) in June 2023 is estimated to be USD 60.09 Billion, exhibiting a negative growth of (-) 13.16 per cent over June 2022. Overall imports in June 2023 is estimated to be USD 68.98 Billion, exhibiting a negative growth of (-) 13.91 per cent over June 2022.

Trade deficit improved by 28.26% during April to June 2023 to US\$ 22.59 Billion from US\$ 31.49 Billion in April to June 2022

Merchandise Trade Deficit also improves by 7.9% at USD 57.6 Billion April-June 2023 as compared to USD 62.6 Billion in April-June 2022 **Electronic Goods** export witnessed impressive growth of 45.4 % and 47.1% in June 2023 and April-June 2023 respectively over corresponding period last year

Iron Ore exports show significant increase of 1664.3% in June 2023 as compared to June 2022, and 35 % during April-June 2023 over April-June 2022

Agricultural exports register robust growth; Spices by 18.2% while exports of Fruits and Vegetables by 14.1% Oil Seeds by 25.1%, Oil Meals by 33.2% in April-June 2023 over April-June 2022

Nine States Attain Enhanced Coal Production During 2022-23



India has witnessed the highest ever coal production in the Year 2022-23.

The all India coal production in the year 2022-23 was 893.19 Million Tonne (MT) (Provisional) in comparison to 778.21 MT in the year 2021-22 with a growth of about 14.77%.

Rise in the production of coal has been reported in the States of Assam, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Telangana, Uttar Pradesh & West Bengal in the year 2022-23 in comparison to the previous year.

Fall in the production of coal has been reported in the State of Jammu & Kashmir in the year 2022-23 in comparison to the previous year.

Most of the requirement of coal in the country is met through indigenous production / supply. The focus of the Government is on increasing the domestic production of coal and to eliminate non-essential import of coal in the country.

Increase in domestic production of coal will eliminate non-essential import of coal and can reduce dependence on imported coal in the country.

The **Ministry of Coal** has achieved a remarkable feat with a substantial surge in overall coal production during the month of **May'23**, reaching 76.26 Million Tons (MT), surpassing the figures of the month **May'22 of 71.21 MT**, representing an increase of 7.10%.

Subansiri Dam Project



90% of the total work of the Subansiri Lower Hydroelectric Project has already been completed. The **Subansiri Lower Dam** is an under construction **gravity dam** on the **Subansiri River** in **North Eastern India**. It is located **2.3 km** (1.4 mi) upstream of **Subansiri River** in **Arunachal Pradesh**.

With capacity **2000 MW** (8x250 MW) the dam is officially named **Subansiri Lower Hydroelectric Project (SLHEP)**.

SLHEP is being executed by Indian public sector hydropower company **NHPC Ltd**. Once completed, SLHEP will be the **largest hydroelectric project** in India. On completion, the Subansiri Lower Hydroelectric Project will generate approximately 7,500 million kilowatt-hours of power annually, in a 90%-dependable year.

NHPC Limited commenced construction work of Subansiri Lower Hydroelectric Project in January 2005 after obtaining forest clearance on October 12, 2004. However, due to agitations and protests by local stakeholders, the project construction work was stalled from December 2011 to October 2019. The project construction resumed from October 15, 2019, after the clearance by National Green Tribunal.

What is a gravity dam?

A gravity dam is a dam constructed from concrete or stone masonry and designed to hold back water by using only the weight of the material and its resistance against the foundation to oppose the horizontal pressure of water pushing against it.

PM Kisan 14th installment: Government Releases PM Kisan 14th installment

The **14th installment of Pradhan Mantri Kisan Samman Nidhi** was released. The Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) is a **Central Sector Scheme**. According to the official Twitter Handle of the PM KISAN scheme, the government will release the 14th installment and interact with farmers on July 27, 2023 in Sikar, Rajasthan.

Under the Scheme, an amount of Rs. **6000**/is transferred annually in **three** equal installments of Rs.**2000**/- directly into the Aadhaar seeded bank accounts of the farmers.

The scheme aims at providing financial assistance to cultivable **landholding** farmer families across the country, subject to

certain exclusion criteria, to enable them to take care of expenses related to agriculture and allied activities as well as domestic needs.

Under the PM-KISAN Scheme, the responsibility to identify the beneficiaries and upload their correct and verified data on PM-KISAN portal lies with the respective State/UT Government.

Thereafter, these data go through various levels of verification and validation including Aadhaar/PFMS/Income Tax database. Subsequent to such verification and validation, the benefit of the Scheme is passed on to eligible beneficiaries directly into their Aadhaar seeded bank accounts through DBT.

Under the PM-KISAN Scheme, more than 2.42 lakh crores has been disbursed to more than 11 crore beneficiary farmer families through various installments.

About PM-KISAN Samman Nidhi

- Pradhan Mantri Kisan Samman Nidhi is an initiative by the government of India that give farmers up to Rs. 6,000 per year as minimum income support. The initiative was announced in 2019.
- The scheme is applicable only for landholding farmers. The number of farmers whose land details are seeded on the PM-KISAN Portal is more than 9.53 crore.

Value of Defence Production Crosses Rs1 lakh Crore Mark



The value of defence production in the financial year (FY) 2022-23 has crossed the figure of one lakh crore rupees for the first time, Union Minister of State for Defence Ajay Bhatt on Friday informed the Lok Sabha.

In the last few years, the government has taken several policy initiatives and brought in reforms to encourage indigenous design, development and manufacture of defence equipment by Indian Industry including MSMEs and start-ups, thereby promoting ease of doing business in defence manufacturing & technology in the country.

Government promotes participation of MSMEs/start-ups for development of defence technology under various schemes like Innovations for Defence Excellence (iDEX), Technology Development Fund (TDF), Make procedure under Defence Acquisition Procedure (DAP) 2020.

The DAP 2020 provides special provisions to encourage MSMEs and Start-ups. Moreover, Public Procurement Policy for MSEs Order, 2012 has been implemented at DPSUs under which the price preference is given to MSME bidders under certain conditions. Further, DPSUs and services have uploaded more than 30,000 defence items on 'Srijan portal for indigenisation' and offered them to Industry including MSMEs to become partners in indigenisation process.

Further, Innovations for Defence Excellence (iDEX) was launched in April, 2018 to foster innovation and technology development in Defence and Aerospace by engaging Industries including MSMEs/start-ups. iDEX provides grants/funding and other support to carry out R&D activities for futuristic technologies.

The industries including the MSMEs and start-ups have given an enthusiastic response to iDEX for defence innovation works including design, development and manufacturing of Defence equipment. iDEX has given boost to defence industrial manufacturing ecosystem by promoting formation of Start-ups by individual innovators, and supporting sustenance to existing Start-ups/MSMEs. This has also led to the generation of employment opportunities.

Moreover, to bring MSMEs into the defence supply chain and thereby boost the selfreliance in defence sector in the country and also to contribute towards defence exports, Ministry of Defence has made a scheme of promotion of MSMEs in defence. Under this scheme, workshops/seminars are organised in collaboration with Industry Associations and other stakeholders from different parts of the country.

Nyaya Bandhu program



Under Section 12 of the Legal Services Authority Act 1987, applicants who are marginalized or disadvantaged including ST, SC, victims of trafficking or begging, women or children, PWDs, and other eligible categories, are entitled to get free legal aid & advice through Department of Justice's Nyaya Bandhu program.

Nyaya Bandhu (Pro Bono Legal Services) was introduced the in vear **2017** with the primary goal of establishing a framework for the provision of pro bono legal services across the country. Nyaya Bandhu's primary initiative is to establish a framework for dispensation of pro bono legal services across the country. Under Nyaya Bandhu, practising advocates, interested to volunteer their time and services, are connected, via mobile technology, with eligible marginalised beneficiaries.

Nyaya Bandhu Mobile application (Android/IOS) has been developed and also onboarded on the UMANG platform in collaboration with technical partner CSC e-Governance Pvt. Ltd. Nyay Bandhu (Android Application for legal support)

- Under Nyaya Bandhu, practising advocates interested to volunteer their time and services are linked with eligible marginalised beneficiaries via mobile technology.
- In collaboration with technical partner CSC e-Governance Pvt. Ltd., the Nyaya Bandhu Mobile application (Android/iOS) was developed.
- This application provides assistance to those groups who are covered under section 12 of the Legal Service Authority Act 1987 which includes members of a Scheduled Caste or Scheduled Tribes, victims of trafficking in human beings or beggars, women or children, PWDs, and other eligible categories.

Government introduces Ayush Visa



With a view to promoting India as a destination for traditional medical treatments, **Ministry of Home Affairs** has notified the creation of a new category of Ayush (AY) visa for foreign nationals for

treatment under Ayush systems/Indian systems of medicine.

The visa is aimed at facilitating travel for foreigners seeking treatment under Ayush systems/traditional systems of medicine, including therapeutic care, wellness, and yoga.

A new chapter i.e. chapter 11A – Ayush Visa has been incorporated after Chapter 11 -Medical visa of the Visa Manual, which deals with treatment under the Indian systems of medicine and accordingly necessary amendments has been made in various chapters of the Visa Manual, 2019.

According to Union Minister of Ayush and Ports, Shipping & Waterways Sarbananda Sonowal, "The creation of new category of Ayush (AY) visa for foreign nationals seeking treatment under Ayush systems/Indian systems of medicine is a significant step.

It will boost Medical Value Travel in India.

It is pertinent to mention that Prime Minister Narendra Modi had announced a creation of a special Ayush Visa category for facilitating foreign nationals travel to India seeking Ayush therapy, at Global Ayush Investment and Innovation Summit (GAIIS) in Gandhinagar, Gujarat in April 2022.

Introduction of Ayush Visa category is part of India's roadmap for the Heal in India initiative of the government, which is intended at promoting India as a medical value travel destination. Ministry of Ayush and the ministry of Health & Family Welfare are working together to develop a one stop Heal in India portal to promote India as a Medical tourism destination of the world.

Global Wellness economy

Medical Value Travel has seen significant growth in India in recent years. According to the report 'The Global Wellness Economy: Looking beyond COVID' by the Global Wellness Institute (GWI), the **Global Wellness economy** will grow at 9.9% annually.

Ayush based healthcare & Wellness economy

Ayush based healthcare & Wellness economy is estimated to grow to **\$70 billion** by 2025. Ministry of Ayush has been working on many fronts to promote Ayush system of treatment national and globally. Recently, a Memorandum of Understanding (MoU) with India Tourism Development Corporation (ITDC), Ministry of Tourism, Gol was signed to work together for the promotion of Medical Value Travel in Avurveda and other traditional systems of medicine.

Pradhan Mantri Ujjwala Yojana (PMUY)



To make Liquified Petroleum Gas (LPG), a clean cooking fuel, available to the rural and deprived poor households, Government launched Pradhan Mantri Ujjwala Yojana in May 2016, to provide deposit free LPG

connections to adult women of poor households.

Pradhan Mantri Ujjwala Yojana (PMUY) was launched on 01.05.2016 to release deposit free LPG connection in the name of adult woman member of poor households across the country.

The target to release **8 crore** connections was achieved in September, 2019.

To cover the remaining poor households, PMUY phase-2 (Ujjwala 2.0) was launched in August 2021 with a target to release 1 crore additional PMUY connections, which was achieved in January 2022.

Subsequently, the Government decided to release 60 lakh more LPG connections under Ujjwala 2.0 and as on 01.01.2023, the target of 1.60 crore Ujjwala 2.0 connections has already been achieved.

Under Ujjwala 2.0, a special provision has been made for migrant families who can use a self-declaration instead of Proof of Address and Ration Card to apply for a PMUY connection.

A total of 5.43 lakh LPG connections have been released to migrant households under Ujjwala2.0.

As on 01.07.2023, there are about 9.59 crore PMUY beneficiaries, out of which 8.41 crore have taken at least one refill during 2022-23.

LPG consumption of PMUY beneficiaries is monitored on regular basis. Consumption of domestic LPG by households depends on several factors like food habits, household size, cooking habits, price, availability of alternate fuels etc. **Overall Mineral Production Increases by 6.4% in May, 2023**



The Ministry of Mines says India's overall mineral production increased by 6.4 per cent in May 2023 over the last year and cumulative growth touched 5.8 per cent from April to May 2022-23.

The index of mineral production of the mining and quarrying sector for the month of May stood at 128.1.

The production level of important minerals in May 2023 was coal 762 lakh, lignite 35 lakh, petroleum (crude) 25 lakh, iron ore 253 lakh, limestone 387 lakh tonnes each, natural gas (utilised) 2838 million cu. m and gold 97 kg.

The ministry added that important minerals showing positive growth during May 2023 over May 2022 included manganese ore (40.4 per cent), magnesite (28.2 per cent), copper conc. (24.4 per cent), chromite(16.3 per cent), iron ore (13.6 per cent), limestone (10.1 per cent), lead conc.(9.7 per cent), coal (7 per cent), bauxite(4.8 per cent) and zinc conc.(2.9 per cent).

DGCA signs MoU with EU Aviation Safety Agency



The Directorate General of Civil Aviation (DGCA) India has signed a Memorandum of Understanding (MoU) with the European Union Aviation Safety Agency (EASA) for cooperation in Unmanned Aircraft Systems and Innovative Air Mobility.

This MoU will focus on collaboration on unmanned aircraft and innovative air mobility between the two civil aviation authorities.

This collaboration would include cooperation between **DGCA** and **EASA** in the areas of development of certification standards and environmental standards and related requirements for the certification and use of unmanned aircraft systems and innovative air mobility operations which includes licensing of personnel, training, air traffic management and infrastructure, including Unmanned Aircraft System Traffic Management (UTM) standards and services.

The **MoU** will also ensure regular information sharing between the two authorities on the technological developments and research in this area and also their respective strategies for outreach to relevant stakeholders. Further, the MoU will result in collaboration in conducting conferences, workshops, training programmers by DGCA and EASA in this area.

The signing of this MoU is expected to result in harmonized standards and accelerated growth of Indian unmanned aviation sector.

During **EU-India Aviation Summit** held in New Delhi on 20th April 2023, DGCA had signed a letter of intent (LoI) on Unmanned Aircraft Systems and Innovative Air Mobility with the European Union Aviation Safety Agency (EASA).

The Ministry of External Affairs (MEA) has announced that India has signed a Memorandum of Understanding (MoU) with Tanzania to establish the first IIT branch abroad, in Zanzibar-Tanzania. The Tanzania campus is expected to open in **October 2023**, with 50 undergraduate and 20 master's students in its first batch.

The agreement was signed between India's Ministry of Education, IIT Madras and Tanzania's Ministry of Education and Vocational Training-Zanzibar.

This agreement was inked in the presence of External Affairs Minister S Jaishankar and Zanzibar's President Hussein Ali Mwinyi during his four-day visit to Tanzania in July.

The campus, named IIT Madras at Zanzibar, is the first ever IIT campus to be set up outside India.

IIT Madras is expected to launch four undergraduate and five postgraduate programmes from the Zanzibar campus.

While IIT Madras will design academic programmes, curricula and student selection criteria, the capital and operating expenditure will be met by the government of Zanzibar-Tanzania for the new campus. Students graduating from this camps will be awarded IIT Madras degrees.

Apart from Tanzania, two more global campuses of IIT Delhi and IIT Kharagpur are set to come up in **Abu Dhabi** and **Kuala Lumpu**r.

The setting up of campus of IIT Madras in Zanzibar is also in line with the National Education Policy (NEP) 2020

National Education Policy recommends that "high performing Indian universities will be encouraged to set up campuses in other countries". **Zanzibar** is an archipelago off the coast of east Africa that united with Tanganyika in 1964 to form the United Republic of Tanzania. It is a semi-autonomous region of Tanzania.

Lothal is an important Indus Valley site in Gujarat. Archaeological excavations have discovered the oldest man-made dockyard, over 5000 years old, in Lothal.

The foundation stone for the NMHC project was laid by Prime Minister Narendra Modi in March 2019. The project is part of the Sagarmala Programme of the Ministry of Ports, Shipping and Waterways.

Comprising of a maritime museum, lighthouse museum, maritime theme parks, amusement park centres, etc., NMHC will showcase the maritime heritage of the country from ancient to modern times by adopting an edutainment approach using the latest technology to spread awareness about India's maritime heritage.

"Currently, India has 40 Sites in the UNESCO World Heritage List and 52 sites (including 6 added in year 2022) in the UNESCO Tentative List," Union Minister for Culture, Tourism and Development of North Eastern Region (DoNER) G Kishan Reddy said in a reply in the Lok Sabha.

Archaeological Survey of India (ASI) follows its own guidelines for the conservation of Centrally protected monuments as per the National Conservation Policy, 2014.

There are **3,696** Centrally protected monuments/sites under the jurisdiction of Archaeological Survey of India (ASI). Conservation of monuments/sites is taken up as per the requirement and availability of resources, the Minister said.

Inclusion of any property in **Tentative List** is a prerequisite condition for onward inclusion in the World Heritage List. Augmentation of Tentative List is a continuous process. As per UNESCO Operational Guidelines, 2021, only one property, either cultural or natural, can be nominated for the inscription process annually. Additionally, inclusion of any site requires fulfilment of Criteria, meeting the condition of authenticity and integrity and providing justification of Outstanding Universal Value, the Minister said.

This rich embroidery tradition, predominantly upheld by the skilled women of the Lambani community, serves as a vital source of livelihood and sustenance, intertwining practices with economic living empowerment.

Political Parties now able to file financial accounts online



The Election Commission of India (ECI) has launched a web

portal (https://iems.eci.gov.in/)for

political parties to file financial statements online. Every political party needs to submit their financial statements as per the Representation of People Act, 1951.

Every political party is bound to disclose its financial accounts, transactions, and donations under the Representation of the People Act, 1951.

The political parties not wishing to file the financial report through online mode will have to convey the reasons for not filing online to the Commission in writing and may continue to file its reports in hard copy along with CDs/Pen drive in the prescribed formats.

The Election Commission of India (ECI), in turn, publish all such reports online, along with a letter of justification sent by the party for not filing financial statements online.

The measure has been enabled with the launch of a new web-portal (https://iems.eci.gov.in/) to facilitate the online filing of Contribution Report, Audited Annual Account and Election Expenditure Statement by the Political Parties.


The online availability of the data is expected to enhance the level of compliance and transparency.

These financial statements are required to be submitted by political parties to the Election Commission/Chief Electoral Officers of States/Union Territories.

The on-line portal has a facility for sending reminders in the form of messages on the registered mobile number and registered emails of the authorised representatives of the political party so that the dates of compliances are not missed.

A comprehensive guiding manual with graphical representations, and FAQs have also been sent to the political parties explaining the online module and the process of filing reports online. To give further guidance on the on-line filing, the ECI would also organise a hands-on training programme for the designated person(s) from various political parties.

India & Panama sign MoU on Electoral Cooperation



The Election Commission of India (ECI) and Electoral Tribunal (ET) of Panama have signed a Memorandum of Understanding in Panama City to establish the institutional framework for their ongoing cooperation in the field of election management and administration.

A three member ECI delegation led by Chief Election Commissioner of India **Rajiv Kumar** held interactions with Presiding Magistrate, Electoral Tribunal of Panama Alfredo Juncá Wendehake on strengthening collaboration and knowledge exchange between the two **Election Management Bodies (EMBs).** The MoU reflects the ECI's ongoing commitment to engage with electoral bodies across the globe and strengthen the democratic processes worldwide.

ECI has been expanding its links and cooperation with foreign Election Management Bodies (EMBs) through its 'International Cooperation Programme'. Svamitva Yojana



Ministry of Panchayati Raj (MoPR) is implementing **Central** Sector Scheme **SVAMITVA (Survey of Villages and Mapping** with Improvised Technology in Village Areas) with the aim to provide the 'Record of Rights' to village household owners possessing houses in inhabited areas in villages. Legal ownership rights (Property cards/Title deeds) are issued by mapping of land parcels using drone technology.About 6.62 lakh villages across the country will be surveyed in this scheme from 2021 to 2025, using varied technology including drones to collect property data.

The initial phase of the scheme was implemented during 2020-21 in select villages of Maharashtra, Karnataka, Haryana, Uttar Pradesh, Uttarakhand, Madhya Pradesh, Punjab and Rajasthan.

Under this scheme mapping of land parcels using drone technology is done by the Survey of India (**Sol**).

States need to sign Memorandum of Understanding (MoU) with Sol for implementation of the scheme. So far 31 States/Union Territories (UTs) have signed MoU with Sol.

Benefits of SVAMITVA Scheme:

- The scheme is intended to reduce property disputes by providing accurate land records while boosting financial liquidity.

A National Conference on Drug Trafficking and National Security was held in New **Delhi** under the chairmanship of Union Home Minister Amit Shah.



It will act as a hub for promoting collaboration among UPU member countries in the Asia Pacific region, encouraging innovation and facilitating knowledge sharing to enhance postal services.

India also announced contribution of USD 2,00,000 over a period of four years towards the UPU's Development and Technical Assistance activities through Asia Pacific

Postal Union. This financial contribution aims to support capacity building, infrastructure development, and other essential activities to strengthen the postal sector in the region.

Establishment of the UPU Regional Office in India is a significant step towards India's commitment for South-South cooperation and its active role in global postal development.

It will also create opportunities for joint initiatives and capacity building programmes that will enhance the quality of postal services, cross-border e-commerce and contribute to economic development and social well-being.

4th ETWG Meeting Under India's G20 Presidency



The **4th Energy Transitions Working Group** (ETWG) Meeting under India's G20 Presidency was held began in Goa from July 19, 2023.

The 4th Energy Transitions Working Group Meeting (ETWG) under India's G20 Presidency is being held in Goa from July 19th to 22nd, 2023. 100 delegates from G20 member countries, special invitee countries, and several International Organisations are participating in the two-day meeting.

The discussions in the 4th ETWG meeting in Goa will continue to build on the first three meetings in **Bengaluru**, **Gandhinagar**, and **Mumbai** respectively, to identify and promote best practices, policies, and innovative approaches that support a just and inclusive energy transition.

On the sidelines of the main event, the **14th Clean Energy Ministerial** and **8th Mission Innovation Meeting (CEM14/MI-8)** too commenced on Day 1 with great enthusiasm and active participation from more than 34 member countries.

The theme of CEM14/MI-8 is 'Advancing Clean Energy Together.'

The 3rd the Energy Transitions Working Group Meeting (ETWG) was held in Mumbai from 15th to 17th May, 2023. The three-day 100 delegates meeting saw over representing G20 member countries, special invitee countries and International Organisations such as International Energy Agency (IEA), Word Bank and World Energy Council India engaging in discussions and deliberation on Priority Areas.

The first meeting of ETWG was held in Bengaluru in Karnataka, in February, 2023 and the second ETWG deliberation was held in Gandhinagar, Gujarat from 2nd to 4th April, 2023. The discussions and deliberations in Mumbai continued to build on the first two ETWG meetings to identify and promote best practices, policies, and innovative approaches that can support a just and inclusive energy transition.

The six priority areas, outlined under India's Presidency, include

(i) Energy transition through addressing technology gaps

(ii) Low-cost financing for energy transition

(iii) Energy security and diversified supply chains

(iv) Energy efficiency, industrial low carbon transitions and responsible consumption,

(v) Fuels for Future (3F)

(vi) Universal access to clean energy and just, affordable, and inclusive energy transition pathway.

Scheme of Polytechnics (Current Affairs)

CDTP



Community Development Through Polytechnic

Ministry of Skill Development and Entrepreneurship (MSDE) is implementing the Scheme of Polytechnics through Directorate General of Training (DGT).

Under scheme, Community this Development Through Polytechnics (CDTP) is one of the components wherein non-formal, short-term, employmentoriented skill development programmes are provided through Polytechnics to various sections of the community, particularly the rural, unorganized & disadvantaged sections of the society, to enable them to obtain gainful self / wage employment.

The government has revised the guidelines of CDTP in 2022-23 to include the provision of its implementation through National Skill Training Institutes (NSTIs) and Industrial Training Institutes (ITIs) and to extend the coverage to Aspirational and Border Area Districts.

The government has also increased the recurring grant up to **Rs. 19.72 lakhs** from the existing Rs. **17.00 lakhs** per polytechnic per annum under this component. The revised guidelines is available at website dgt.gov.in.

The **CDTP component** is implemented by the **State government** and **Union Territory Administrations** through selected Polytechnics in accordance with guidelines issued by the Central government.

Under the guidelines, the identified institution should target the poor and deprived sections of society in both urban and rural areas specifically women, SCs/STs, OBCs, minorities, school dropouts, street children, physically handicapped, economically weaker sections of the society and other under-privileged persons.

No fee is charged from the trainees under this component and there is no restriction on the age, sex and qualification of the trainees.

Indian Coast Guard rescues NIO research vessel with 36 onboard off Karwar coast



The Indian Coast Guard has successfully
rescued 36 crewmembers,
members,
including eight scientists, on board a
research ship - RV Sindhu Sadhana of
the NationalInstituteof
of
Oceanography (NIO) - in the Arabian Sea off
Karwar Coast in Karnataka on July 27, 2023.

The research vessel had suffered engine failure and was drifting at a speed of 03 knots. It was approximately **20** nautical miles away from the land when the distress signal was received.

The situation was critical as the state-of-theart research vessel of NIO was carrying valuable scientific equipment and research data.

Moreover, the proximity of the ship to the ecologically sensitive Karwar coastline posed an imminent threat of grounding, which could have resulted in a major oil spill and devastating pollution to the pristine marine environment.

Upon receiving the distress call, the Indian Coast Guard immediately swung into action and activated a high-priority rescue operation, dispatching their highly advanced Ship with a skilled team to the area. Recognizing the potential magnitude of the disaster, the Indian Coast Guard got activated to safeguard the Ship so as to protect the fragile ecosystem and save the vessel from running aground.

Despite challenging weather conditions and the vessel's considerable distance from the coastline and size of the ship, the Indian Coast Guard team took the vessel under tow to safely bring it to Goa, thereby executing a seamless rescue operation. The crew members onboard the NIO ship are safe and sound.

Participation Of Females In The MSMEs



To encourage entrepreneurship among women, the **Ministry of Micro, Small and Medium Enterprises (MSME)** implements various schemes.

The Ministry implements Prime Minister's Generation Employment Programme (PMEGP) is a major credit-linked subsidy programme aimed at generating selfemployment opportunities through establishment of micro-enterprises in the non-farm sector by helping traditional artisans rural/urban unemployed and youth.

For women entrepreneurs, higher subsidy is given. Under the Mahila Coir Yojana, the Ministry provides stipendiary training for women artisans in the coir industry and encourage them to set up their own micro enterprises by availing the benefits of PMEGP.

The Credit Guarantee Fund Trust for Micro, and Small Enterprises (**CGTMSE**) provides guarantee cover to collateral and/or third party guarantee free credit facilities extended by eligible Member Lending Institutions to Micro and Small Enterprises. CGTMSE has increased the extent of guarantee coverage of credit to 85% for women entrepreneurs.

As an additional concession to Women Entrepreneurs, CGTMSE has reduced the Annual Guarantee Fee by 10%. Through an amendment to the Public Procurement Policy, the Government has mandated that all Central Ministries/ Departments and Central Public Sector Undertakings should procure at least 3% of their annual procurement from women owned micro and small enterprises.

The Ministry also implements several other schemes for promotion and development of MSMEs, including women owned MSMEs, namely, Micro and Small Enterprises Cluster Development Programme (MSE-CDP), Tool Rooms & Technology Centres, Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Procurement and Marketing Support (PMS) Scheme, Entrepreneurship and Skill Development Programme (ESDP).

The Women Entrepreneurship Platform (WEP) initiated by NITI Aayog facilitates last mile dissemination of all information required by an existing or prospective entrepreneur, including Government and Non- Government initiatives. WEP aims to address the information asymmetry and helps nurture women entrepreneurship.

For all entrepreneurs including women, Atal Innovation Mission (AIM) nurtures innovation among the youth of the country through Atal Tinkering Labs, Atal Incubation Centers and Atal Community Innovation Centers. AIM is a flagship initiative of the Government of India. The Government also launched Startup India initiative in 2016 with an aim to build a stronger ecosystem for nurturing India's startup culture that would further drive our economic growth, support entrepreneurship, and enable large-scale employment opportunities. It, inter alia, assists in strengthening women entrepreneurship, through policies and initiatives, and creation of enabling networks.

The Deendayal Antyodaya Yojana – National Livelihoods Mission and Start up Village Entrepreneurship Programme of the Ministry of Rural Development aim to help women Self Help Group members in setting up micro units.

The percentage of women-owned MSMEs registered on the Udyam Aadhaar portal and Udyam Registration portal during the period 18.09.2015 to 30.06.2020 and 01.07.2020 till 27.07.2023 in the country and in Assam is given in Annexure.

National Green Tribunal (NGT)



Justice Adarsh Kumar Goel who had taken over National Green Tribunal as Chairperson on 06.07.2018 com pleted his tenure of 5 years on **06.07.2023**. During his period of 5 years, Justice Goel had brought in several innovative and people friendly methods for providing justice in the area of environment.

The Central Government has appointed Justice **Sheo Kumar Singh-I**, Judicial Member of the National Green Tribunal (NGT), to act as the Chairperson of the NGT until the date on which a new Chairperson is appointed.

The National Green Tribunal was established in 2010 under the National Green Tribunal Act 2010. It was established for effective and expeditious disposal of cases relating to environmental protection and conservation of forests and other natural resources including enforcement of any legal right relating to environment and giving relief and compensation for damages to persons and property and for matters connected therewith or incidental thereto.

National Green Tribunal is a specialized **body** equipped with the necessary expertise to handle environmental disputes involving multi-disciplinary issues. The Tribunal shall not be bound by the procedure laid down under the Code of Civil Procedure, 1908, but shall be guided by principles of natural justice. National Green Tribunal was established by Government of India under National Green Tribunal Act, 2010. The main objective of National Green Tribunal is efficacious and expeditious handling cases related to environmental protection, forest conservation, natural resource preservation, pollution compensation, and environmental restitution.

Since inception National Green Tribunal has been taking up cases relating to environment such as Air pollution, Noise pollution, Water pollution, Industrial pollution, waste disposal etc.

Composition of National Green Tribunal

- With Headquarters in Delhi, NGT consists of chairperson who should have been retired as Supreme Court judge.
- The Judicial members of the tribunal should have been retired as Judge of the High Courts.
- National Green Tribunal bench consists of ten Judicial Members and ten Expert Members.
- Any person having a professional qualification with 15 years minimum experience in the subjects of forest conservation and environment and similar areas can qualify for expert member.

Places

The principal National Green Tribunal bench is located in Delhi, with other benches sitting in Bhopal, Pune, Kolkata and Chennaiy)

India Betting Big on Green Hydrogen



A three-day International Conference on Green Hydrogen (ICGH-2023) was held during 5th – 7th July 2023 to highlight India's significant investment in green hydrogen and its transformative impact on the country's energy landscape.

The conference was organized by the Ministry of New and Renewable Energy, in partnership with the Ministry of Petroleum and Natural Gas, Council of Scientific and Industrial Research, Office of Principal Scientific Advisor to Government of India and the Confederation of Indian Industry.

ICGH 2023 provides a platform for fostering partnerships to realize a vision of a clean and green planet.

India is betting big on making a transition towards renewable energy and reducing dependence on fossil fuels.

The objective of ICGH 2023 was to learn from the experiences of other countries leading the development and deployment of green hydrogen.

Centre Formulates In-Principle Approval To Set Up 21 New Greenfield Airports



The Indian Government has granted 'In-Principle' approval for the establishment of **21** new greenfield airports under the **Greenfield Airports (GFA) Policy, 2008**.

These airports are planned to be set up in states like Goa, Maharashtra, Karnataka, Madhya Pradesh, Uttar Pradesh, Gujarat, Puducherry, Andhra Pradesh, West Bengal, Sikkim, Kerala, and Arunachal Pradesh.

According to the Ministry of Civil Aviation, out of the 21 new airports, **Mopa (Goa)**, **Navi Mumbai** (Maharashtra), **Noida-Jewar** (UttarPradesh), **Bhogapuram** (Andhra Pradesh), **Karaikal** (Puducherry), **Dholera** and **Hirasar** (Gujarat) are the seven green international airports.

Other 14 airports are namely, Shirdi and Sindhudurg in Maharashtra, Kalaburagi, Vijayapura, Hassan and Shivamogga in Karnataka, **Dabra** (Gwalior) in Madhya Pradesh, Kushinagar in Uttar Pradesh, Dagadarthi, Orvakal (Kurnool) in Andhra Pradesh, Durgapur (Andal) in West Bengal, **Pakyong** in Sikkim, **Kannur** in Kerala in Arunachal and **Hollongi** (Itanagar) **Pradesh** across the country.

11 Greenfield airports have been operationalised. The airports at Durgapur, Shirdi, Kannur, Pakyong, Kalaburagi, Orvakal (Kurnool), Sindhudurg, Kushinagar, Itanagar, Mopa and Shivamogga have been operationalised.

What are Greenfield Airports? A greenfield airport is an aviation facility with greenfield project characteristics. They are built from scratch on previously undeveloped or empty land. The term "greenfield" emphasises their environmentally friendly characteristics, as they aim to minimise the impact on nature during the construction and commissioning processes.

Introduction of Greenfield Airports in India The Greenfield Airports (GFA) Policy was formulated by the government in 2008. This policy aims to provide detailed guidelines, procedures, and steps for the establishment of Greenfield airports throughout the country.

G20 Environment and Climate Ministers' Meet in Chennai

INS Sahyadri and INS Kolkata in Jakarta



Two frontline Indian Naval ships INS Sahyadri and INS Kolkata arrived in Indonesia's Jakarta on 17 July 2023 to participate in the Maritime Partnership Exercise (MPX) with the Indonesian Navy. The ships were accorded a warm welcome by the Indonesian Navy.

During the port call, personnel from Indian and Indonesian navies will engage in a wide range of professional interactions, joint yoga sessions, sports fixtures and cross-deck visits, aimed at strengthening mutual cooperation and understanding between the two navies.

Upon completion of the operational turnaround, the two ships will also participate in a Maritime Partnership Exercise (MPX) at sea with the Indonesian Navy towards further bolstering the high degree of interoperability that already exists between the two navies.

INS Sahyadri is the third indigenously designed and built **Project-17 class stealth frigate** and **INS Kolkata** is the first indigenously designed and built stealth destroyer of the **Project-15A class**. Both the ships have been built at Mazagon Dock Shipbuilders Ltd, Mumbai.
